Type-Approval Procedure

Information System of the German Type-Approval Authority

Regulation (EU) 2017/1151

Transmission of the Inspection Transparency Package according to Regulation (EU) 2017/1151 for the ISC database.

This IST replaces IST No. 03-19

Issue/Statement of the problem:

According to Article 5(12) of Regulation (EU) 2017/1151, as last amended by Regulation (EU) 2023/443, the manufacturer shall provide a test transparency data package to the type-approval authority that granted the emission or vehicle type approval in order to perform the test according to Annex II, point 5.9. Furthermore, it is required that the manufacturer uploads to the ISC platform all required data for its vehicles.

The following describes the requirements imposed by the Federal Motor Transport Authority (KBA) on the transparency lists and their provision.

Result:

The manufacturer submits the application documents for approval without transparency lists. The emission type approval to be granted is issued by means of an ancillary clause with resolutive effect. This requires that the transparency lists - depending on which event occurs earlier - must be submitted to the KBA or uploaded to the ISC platform before the start of production of the vehicle or no later than four months after the emission type approval is granted.

The manufacturer is responsible for the timely fulfillment of the ancillary clause.

The KBA considers the requirement for the manufacturer to supply the type approval authority to be fulfilled if the manufacturer has uploaded the required data to the ISC platform.

If it is not possible for certain vehicles (e.g. multi-stage vehicles) to upload the required data to the ISC platform, then the data package is to be sent by the manufacturer by e-mail to the e-mail address Transparenzlisten@kba.de. The subject of the e-mail must contain at least a reference to the type approval number with supplementary status and the type designation. This information can also be given in the message text in the case of a collective transmission.

The file name of the corresponding list shall contain at least the type approval number as well as the designation whether it is transparency list 1 or 2. In the case of transparency list 2 it must also be indicated whether it is data set 1 or 2.

Example for the reference to the type approval in the subject: Transparency list e1*715/2007*2018/1832DG*2248*00; Type AB. Examples for file names:

e1*715/2007*2018/1832DG*XXXX*YY; L1 e1*2007/46*XXX*YY; L2; D1 LX = Transparency list 1 or 2

DX = Data set 1 or 2

If the approvals are a correction or revision, then this must be indicated in the file name and also in the subject of the e-mail by Rev.XX or Korr.XX.

For each change to the emission type approval (extension, revision or correction), updated transparency lists must be sent to the KBA or uploaded to the ISC platform according to the described procedure.

Application date of the IST:

The procedure described above is to be applied with the publication of the IST to the type approvals which are issued according to the current status of the regulation (VO (EU) 2023/443).
